**« JACQUES LEROY » INTERNATIONAL PRIZE
STUDENT COMPETITION**

Dear Sir, dear Madam,

The Union Internationale des Avocats (International Association of Lawyers -UIA), established in 1927, is the oldest association of lawyers. It brings together Bars and Lawyers' Associations that represent over 2 million lawyers as well as thousands of individual members spread throughout the world. As a pluri-cultural and multilingual association, its main purpose is the defence and future of the legal profession within the national and international contexts.

Since it believes that law students can also help in promoting human rights in the corporate world, **UIA is organising a major event for law students for the fourth time: the Jacques Leroy international prize will reward a law student of less than 30 years for his or her legal work.**

Students who wish to participate in this prize must send a dissertation (plea, study, commentary of a practical case) before **June 30, 2013** that deals with the following theme: "Fair Trade: how can we establish rules that are specific and realistic?".

The winner will be rewarded with participation in our annual congress that will be taking place in Macau (China) from October 31 to November 4, 2013, including travel costs, accommodation and a cash prize of € 1000, as well as free membership in the UIA for a year.

Thus, we will be highly grateful if you could kindly put up our posters and place our leaflets in a visible space of your institution in order to provide students an easy access to this information thereby enabling them to participate in this prize.

OBJECTIVES:

- To promote the basic principles of the legal profession;
- To contribute to the professional growth of its members through experience sharing;
- To intervene in favor of imprisoned or persecuted lawyers.

The UIA currently has several thousand individual members and hundreds of collective members (bar associations, federations and organizations) from over 110 countries.

KEY INFORMATION

Candidates must send the UIA a file containing the following information:

- their written entry, which must be between 15,000 and 20,000 characters long (spaces included);
- a summary presentation of the entry in 2,000 characters (spaces included);
- a curriculum vitae;
- a letter introducing the candidate written by one of the candidate's University law professors;
- proof of being enrolled at their University (photocopy of a valid student card or a certificate issued by the University).

These documents may be written in English, French or Spanish.

Entries must reach the UIA by letter or email by June 30, 2013 at the latest.

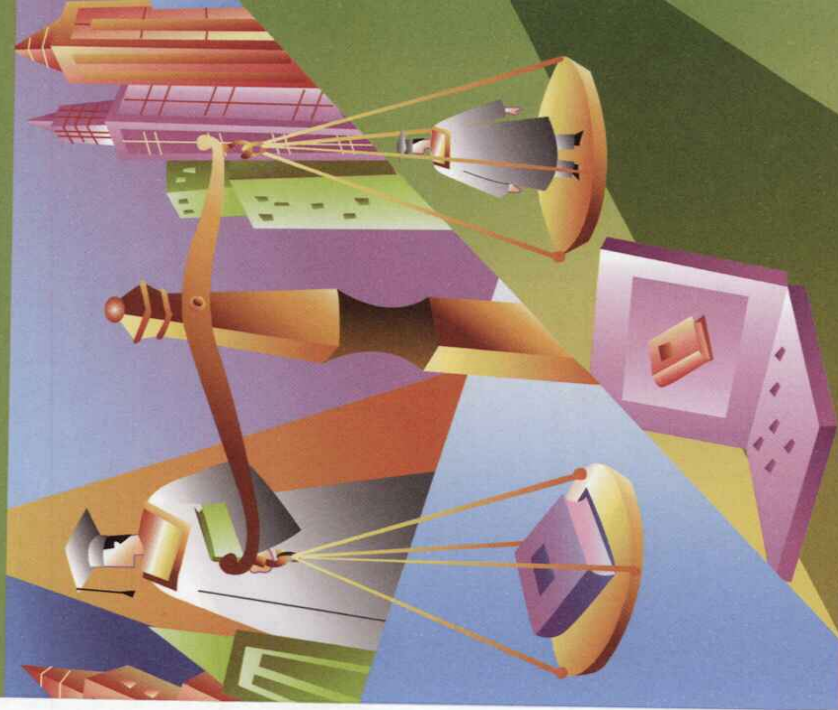

The Union Internationale des Avocats (UIA - International Association of Lawyers) invites all law students to write an entry for the Jacques Leroy International Prize – Business and Human Rights.

BUSINESS AND HUMAN RIGHTS: WHAT WILL THE KEY ISSUES BE TOMORROW?

The globalization of the economy, the demanding nature of the markets and financial deregulation are all phenomena that have profoundly affected the business world. Trade is continually imposing its diktat, to the detriment of its contributors and beneficiaries, e.g. employees, consumers and clients.

From a legal standpoint, as the privileged defender of citizens' rights, lawyers are increasingly called on by the victims of actions that breach their fundamental rights, which directly or indirectly result from corporate activities.

The purpose of the Jacques Leroy Prize is to reward a law student who, in writing a dissertation, study or any other research paper, helps raise awareness of human rights in the business world, and thus offers possible solutions to rationalize the societal responsibility of companies from a legal standpoint.

WHO CAN ENTER THE COMPETITION?

All law students under 30 who are enrolled in a university or law school.

WHAT SHOULD BE SUBMITTED TO THE COMPETITION?

A written document (15,000 – 20,000 characters) in the form of a trial argument, dissertation, study or commentary on a practical case.

ON WHICH SUBJECT?

The 2013 topic is **"Fair Trade: how can we establish rules that are specific and realistic?"**

WHO SELECTS THE WINNER?

A jury of business and/or human rights lawyers will be selected by the Union Internationale des Avocats. The jury members, of various nationalities, will have two months to study the documents submitted by students, which may be written in English, French or Spanish.

WHO ANNOUNCES THE RESULT?

As soon as the decision is reached, the winner will be notified by post, email or telephone.

WHAT DOES THE WINNER RECEIVE?

- A cash prize of € 1,000.
- Free registration at the UIA Congress in Macau from October 31 to November 4, 2013.
- Transportation and accommodation in Macau from October 31 to November 4, 2013.
- A year's free membership of the UIA for the calendar year following the award of the prize.

WHEN AND HOW IS THE PRIZE PRESENTED?

During the opening ceremony of the Macau Congress on October 31, 2013, the jury President or the UIA President will present the prize to the winner.

The winner will have the possibility of presenting the winning document during the working session held by the *Business and Human Rights Commission*.

WHY ENTER THIS COMPETITION?

Working on subjects that are at the forefront of current affairs and presenting one's work to a panel of experienced professionals are both extremely rewarding experiences for a future lawyer.

WHO IS JACQUES LEROY?

Jacques Leroy was President of the UIA in 2003-2004. He was a lawyer in Brussels, Belgium, who was specialized in labor law. He was very committed to the work of the association and unfortunately passed away prematurely. This prize is dedicated to him.
