# Master's Degree Programme in International Human Rights Law Autumn 2013 - Spring 2015, in Turku/Åbo, Finland

## The Master's Degree Programme

The Master's Degree Programme in International Human Rights Law is designed to prepare its graduates for challenging human rights careers in international organizations, non-governmental organizations and public administration. It will also provide the requisite background for advanced human rights law research. Successful completion of this two-year full-time programme results in the award of a Master of Social Sciences (M. Soc. Sc.) degree. The Programme Director is Ms. Catarina Krause (Deputy Director of the Institute for Human Rights).

## Structure of the Programme

The programme (120 credits) consists of the following modules: (a) compulsory human rights law courses (90 credits) including a research seminar and a master's thesis in international human rights law, (b) compulsory language studies (5 credits) and (c) optional courses (25 credits), which may include courses offered by the two universities in Turku / Åbo within Turku Law School as well as courses offered by Nordic and international partner universities.

### Admission

Participation is limited to 10 students. The programme is open to those holding a law degree or another bachelor's degree with at least 45 credits / ECTS in law or other relevant subject(s).
